The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

## About the qualification comparison

UHR has assessed the foreign qualification in comparison to a Swedish degree level. A more precise comparison to a Higher Education Diploma or a Bachelor's degree would depend, among other things, on the higher education institution in the country of study at which the qualification was studied. The assessment refers to qualifications completed in the Islamic Republic of Afghanistan before August 2021.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Degree of Bachelor

<b>Duration</b>	4 - 6 years
<b>Credits</b>	The country has no national credits system.
<b>Information about the qualification</b>	The qualification gives access to Master's level programmes in Afghanistan. Admission to master's education depends, among other things, on which university the education has been studied in Afghanistan. The education documents are usually issued in three languages (English, Dari and Pashto).
