Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

### About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Degree of Doctor.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

<b>Duration</b>	3 years
<b>Credits</b>	The extent of studies is usually calculated as the number of hours.
<b>Information about the qualification</b>	<p>The qualification was completed before the Bologna reform and ceased in 1995.</p> <p>The qualification includes courses, research and a thesis that has been defended at a public defence.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Bulgarian Qualifications Framework (BQF)</a></p> <p>The national qualifications framework (BQF) has 9 levels, where 0 is the lowest and 8 is the highest.</p>
<b>NQF level</b>	Qualifications completed before the Bologna reform have not been assigned a level.
<b>Recognised higher education institutions</b>	<p><a href="#">Register of Higher Education Institutions</a></p> <p>Please note the country can have additional recognised education institutions.</p>
