Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

About the qualification comparison

UHR assesses the foreign qualification as comparable to a vocational qualification at upper secondary level in Sweden. The qualification prepares for work in a specific occupation. The occupational title is indicated on the educational documents.

The foreign qualification does not give access to higher education in Sweden. For information about other ways of meeting the higher education entry requirements, please see Studera.nu.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Facts about Svjedodžba o završnome radu (Vocational Secondary Education Certificate (4-year)) (from 2010)

Duration	4 years The qualification is based on 8 years of schooling.
Information about the qualification	The qualification was introduced in 2010. The qualification prepares for work in a specific occupational field. For access to higher education study, a State Matura examination (državna matura) is required.
National Qualifications Framework (NQF)	Croatian Qualifications Framework (CROQF) The national qualifications framework (CROQF) has 10 levels, where 1 is the lowest and 8.2 is the highest.
NQF level	4.2
EQF level	4

The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.

What do the abbreviations mean?

- SeQF – The Swedish National Qualifications Framework
- EQF – European Qualifications Framework
- Bologna Framework – Qualifications Framework for the European Higher Education Area (QF- EHEA)
