## About the qualification comparison

UHR has assessed the foreign qualification in comparison to a Swedish degree level. A more precise comparison to a 60-credit or 120-credit Master's degree can only be provided on the basis of individual documentation.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Licentia in Philosophia (Degree of Licentiate in Philosophy)

<b>Duration</b>	2 years
<b>ECTS</b>	120 credits
<b>Information about the qualification</b>	The qualification is focused on philosophy. The qualification may include a degree project. The qualification gives access to doctoral-level programmes in the Catholic Church's global education system.
<b>National Qualifications Framework (NQF)</b>	<a href="#">Qualifications Framework of the Holy See</a>  The national qualifications framework (higher education) has 3 levels, where 1 is the lowest and 3 is the highest.
<b>NQF level</b>	2
<b>Bologna level</b>	2
<b>Recognised higher education institutions</b>	<a href="#">Higher education of the Catholic Church</a>  The Holy See's higher education system is global with universities in about 80 countries.  Please note the country can have additional recognised education institutions.
<b>Country information</b>	The Holy See's qualifications framework only includes higher education qualifications.
