About the qualification comparison

UHR has assessed the foreign qualification in comparison to a Swedish degree level. A more precise comparison to a 60-credit or 120-credit Master's degree can only be provided on the basis of individual documentation.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Facts about Degree of Master

Duration	<p>1 - 2 years</p> <p>Research Masters Degree programmes are typically of two years' duration, although they are not credit rated.</p>
ECTS	60 - 120 credits
Information about the qualification	<p>The qualification may include a degree project. The qualification gives access to doctoral-level programmes in Ireland. It is common to enter a Masters research programme, and then transfer to a Doctoral programme after one year on the Masters research programme.</p>
National Qualifications Framework (NQF)	<p>Irish National Framework of Qualifications</p> <p>The national qualifications framework has 10 levels, where 1 is the lowest and 10 is the highest.</p>
NQF level	9
EQF level	7
Bologna level	2
Recognised higher education institutions	<p>Irish Register of Qualifications</p> <p>List of publicly-funded higher education institutions (universities and colleges)</p> <p>Please note the country can have additional recognised education institutions.</p>
