Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Upper Secondary Diploma.

The foreign qualification gives access to higher education in Sweden. Additional general and specific entry requirements may apply.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Duration	2 years The qualification is based on 11 years of schooling.
Information about the qualification	<p>The qualification was introduced in 1996. Previously the examination was known as Advanced Matriculation Certificate.</p> <p>The qualification prepares for higher education study. For access to higher education study in Sweden, two Advanced Level subjects, three Intermediate Level subjects and the compulsory subject Systems of Knowledge, are required.</p>
National Qualifications Framework (NQF)	Malta Qualifications Framework (MQF) The national qualifications framework (MQF) has 8 levels, where 1 is the lowest and 8 is the highest.

The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.
