The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

### About the qualification comparison

UHR has assessed the foreign qualification in comparison to a Swedish degree level. A more precise comparison to a 60-credit or 120-credit Master's degree can only be provided on the basis of individual documentation.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Degree of Master

<b>Duration</b>	The length of the study programme is 1,5 years.
<b>Credits</b>	180 (national credit) SCQF credits
<b>ECTS</b>	90 credits
<b>Information about the qualification</b>	The qualification may include a degree project. The qualification gives access to doctoral-level programmes in the UK. There are also combined 4/5-year Master's programmes in some subjects that do not build upon a Bachelor's degree. These qualifications are dealt with and evaluated separately.
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Scottish Credit and Qualifications Framework (SCQF)</a></p> <p><a href="#">Framework for Higher Education Qualifications in England, Wales and Northern Ireland (FHEQ)</a></p> <p>The Framework for Higher Education in England/Northern Ireland/Wales (FHEQ) has 5 levels, where 4 is the lowest and 8 is the highest. The national qualifications framework for Scotland (SCQF) has 12 levels, where 1 is the lowest and 12 is the highest.</p>

<b>Country information</b>	The United Kingdom consists of four parts, Scotland has its own education system and qualification framework that is separate from the one set for England, Wales and Northern Ireland.

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

\*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.
