The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Higher Vocational Education Diploma.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

<b>Duration</b>	1 year
<b>Credits</b>	120 SCQF credit points
<b>Information about the qualification</b>	The qualification is a post-secondary vocational qualification in The United Kingdom. The qualification may have different specialisations.
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Framework for Higher Education Qualifications in England, Wales and Northern Ireland (FHEQ)</a></p> <p><a href="#">Credit and Qualifications Framework for Wales (CQFW)</a></p> <p><a href="#">Scottish Credit and Qualifications Framework (SCQF)</a></p> <p><a href="#">Regulated Qualifications Framework for England and Northern Ireland (RQF)</a></p> <p>The national qualifications framework for England, Northern Ireland and Wales (RQF och CQFW) has 8 levels, where 1 is the lowest and 8 is the highest. ## The level of Swedish qualifications and degrees
