About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Upper Secondary Diploma.

The foreign qualification gives access to higher education in Sweden. Additional general and specific entry requirements may apply.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Facts about SQA Advanced Higher

Duration	1 year The qualification is based on 12 years of schooling.
Information about the qualification	The qualification prepares for higher education study. The qualification is made up of examinations at Higher and Ordinary grade. For access to higher education in Sweden students must have at least five different subjects, of which at least three must be on Highers or Advanced Highers level. The remaining two subjects can be from Secondary school (National 5/Intermediate 2/Standard grade/Ordinary grade depending on the year of graduation).
National Qualifications Framework (NQF)	Regulated Qualifications Framework for England and Northern Ireland (RQF) Scottish Credit and Qualifications Framework (SCQF) Credit and Qualifications Framework for Wales (CQFW) The national qualifications framework for England, Northern Ireland and Wales (RQF och CQFW) has 8 levels, where 1 is the lowest and 8 is the highest. The national qualifications framework for Scotland (SCQF) has 12 levels, where 1 is the lowest and 12 is the highest.
NQF level	7 (SCQF)
EQF level	4
Country information	The United Kingdom consists of four parts, Scotland has its own education system and qualification framework that is separate from the one set for England, Wales and Northern Ireland.
