## About the qualification comparison

UHR has assessed the foreign qualification in comparison to a Swedish degree level. A more precise comparison to a 60-credit or 120-credit Master's degree can only be provided on the basis of individual documentation.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Degree of Master

<b>Duration</b>	1 - 2 years
<b>Credits</b>	<p>24 (national credit)</p> <p>The number of credits refers to "semester credits". The US has several different credit systems. Many higher education institutions instead use "quarter credits" with a minimum requirement of 36 credits for master studies.</p>
<b>Information about the qualification</b>	<p>The qualification may include a degree project and a placement. The qualification generally gives access to doctoral-level programmes in the US.</p>
<b>Recognised higher education institutions</b>	<p><a href="#">Council for Higher Education Accreditation (CHEA)</a></p> <p><a href="#">United States Department of Education (USDE) - Office of Postsecondary Education</a></p> <p>UHR only assesses higher education programmes accredited by regional accrediting organisations in the U.S.</p> <p>Please note the country can have additional recognised education institutions.</p>
